#### **4. Presidents Report** presented by Jim Greatorex

On behalf of the Far North Queensland Regional Swimming Association, I have the pleasure in presenting our Regional Report from the 2023-24 season.

#### **Development**

Our regional Development calendar was full of activities for our Development Squads. Three (3) Development Clinics facilitated by Brant Best were held over the season for our National, Age Development and Senior State Squads. Squad, High Performance Squad and National Team. In January, the National Team travelled to the Sunshine Coast for a Development Camp that included two Swimnastic sessions, ocean swim cross training, stroke technique correction session run by Brad Hiller and team bonding activities. We received excellent feedback from swimmers and parents and look forward to delivering another National Team Camp in the 2024-25 season.

#### **Regional Events**

Our regional Short Course Championships were held in 29<sup>th</sup> and 30<sup>th</sup> July 2023 and attracted 236 swimmers. The Long Course Championships held 2<sup>nd</sup> and 3<sup>rd</sup> March 2024 attracted 301 athletes exceeding the previous years' Champs which attracted 268 swimmers.

# **Strategic Direction**

FNQRSA Committee continue to focus on the strategic direction for swimming in the region together with the sustainability of the organisation to lead this activity. The focus for this season was attracting sponsorship to cover the costs relating to delivering the Development Clinics.
